The diverter is air operated by means of a cylinder, and comes complete with electrical solenoid, position confirmation switches and a pressure regulator. The seals deflate when changing position and inflate on position confirmation. The standard model is suitable for handling products with a temperature from -20 °C up to +65 °C, and systems with a maximum working pressure of I bar g. Vacuum applications are also possible.

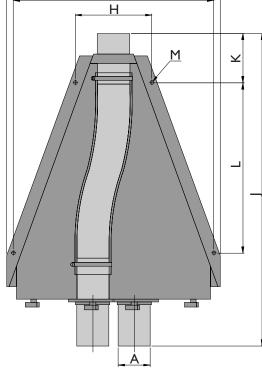

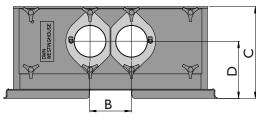
